

**T**he 36th Annual Art & Craft Festival, which traditionally draws more than 8,000 prospective buyers, will be held rain or shine on the beautiful tree-shaded Eagles Mere village greene.

The event presents some of the finest craftsmen to this area with 90 exhibitor spaces available.

This juried show is a paid admission event offering an array of live entertainment and food concessions with part of the proceeds benefitting area charitable organizations.

Well-known as a resort village since the late 1800s, Eagles Mere is located on a cool mountaintop in Sullivan County on RT 42, eight miles off RT 220 in the Endless Mountains north of central Pennsylvania.

# Eligibility

Only artists and craftspeople who design and produce their own work are eligible and must be present during the entire event.

The media to be juried include basketry, clay, fiber, furniture, glass, jewelry, leather, metal, painting, paper, photography, sculpture, wearables, wood and mixed media. Specifically excluded are objects made from dried flowers, commercial kits, imports or manufactured components.

# Display

All spaces will accommodate a 10' D x 10' W display canopy. All booths must be able to withstand weather. No electricity is available.

Oversized Spaces...there is a limited number of oversized booths available. Requests should be indicated on the entry form and sent with a check for \$175. You will be billed for any difference.

# Jury Procedure

Applications must be accompanied by **FIVE SLIDES (absolutely no prints)**. FOUR of which should truly represent the quality of your current work to be exhibited with one item per frame, and ONE of an overall view of your booth display showing merchandise to be sold. If exhibited works differ from the slides submitted to the jury, the artist will be asked to remove such items. All slides must be marked (**NO LABELS**) with the artist's name and medium and an arrow indicating the top of the slide. **Slides MUST be in clear plastic sleeve, or your application will be returned.**

Artists entering two mediums must submit **two separate completed applications**. This application may be photocopied. One artist per booth.

**ALL JURY DECISIONS ARE FINAL.** We will use a juried wait list to fill cancellations.

Submission of an application is a commitment to participate in the Festival. No refunds will be made after April 15, 2006. Artists who cannot show must inform EMVI **in writing** of cancellations. In the event of an emergency, an alternative artist may be assigned to a booth space and a partial refund of the exhibitor fee made to the original artist.
